SPECIAL CONDITION: MS State Law requires that male applicants between the ages of eighteen (18) and twenty-six (26) submit satisfactory documentation of their compliance with the draft registration requirements of the Military Selective Service Act with application. In addition, males between the ages of eighteen (18) and twenty-six (26) who are currently employed shall not be promoted to higher positions until they submit documentation of compliance with the requirements of the Federal Selective Service Act.

MINIMUM QUALIFICATIONS:

LEVEL I-\$23,421.32

1. High school education or GED and one (1) year experience in electrical repair; **OR** any combination of education and experience equivalent to graduation from a four (4) year high school and one (1) year experience in the electrical field.

LEVEL II-\$25,662.65

2. High school education or GED and two (2) years' experience in the electrical field; **OR** any combination of education and experience equivalent to graduation from a four (4) year high school and two (2) years' experience in the electrical field.

LEVEL III-\$28,128.12

3. High school education or GED and three (3) years' experience in the electrical field; **OR** any combination of education and experience equivalent to graduation from a four (4) year high school and three (3) years' experience in the electrical field.
4. Possess a valid state driver's license and if authorized to operate a government vehicle, have the ability to obtain and maintain a US Government motor vehicle operator's ID card. **PROOF OF A DRIVER'S LICENSE MUST BE SUBMITTED WITH APPLICATION**
5. Physical condition of such nature permits continuous, moderately heavy work with the ability to move and lift objects weighing up to 50 pounds.
6. Military membership is desired, but not required.

DUTIES AND RESPONSIBILITIES: (Not all inclusive, will be fully explained during interview)

1. The installation of new and additional electrical work, remodeling, etc.
2. The maintenance and repair of motors, relays, magnetic starters, transformers, etc.
3. Running electrical conduit for installation of new equipment and wiring.
4. Understand the electrical symbols and interpretation of building and electrical prints.
5. Installation and interconnection of transformers.
6. Repair, maintain, alter, or erect any wiring apparatus.
7. Work requires considerable standing, stooping, and bending; works from scaffolds and/or ladders. Work is performed overhead or in stretched, cramped, or awkward positions.
8. Performs work based on the National Electrical Code. Thorough knowledge of codes pertaining to maintenance and installation of electrical systems.
9. Performs other related duties as assigned.
