5. Advances the implementation of natural resources management plans for Camp McCain in accordance with Sikes Act requirements.

6. Managers the prescribed fire program at Camp McCain under the oversight of the MSARNG Fire Management Officer, assists in the suppression of wildfires on the installation. And maintains a minimum certification of FFT2.

7. Performs GPS and GIS duties relating to the environmental program at Camp McCain.

8. Supervises the sale and removal of all timber and timber products at Camp McCain.

9. Operates ATVs/UTVs and other heavy equipment.

10. Performs other environmental duties as assigned.
