MINIMUM QUALIFICATIONS:

1. High school graduate or GED with some college courses towards a degree in journalism **AND** two (2) years of experience and proficiency in journalism, digital still/video acquisition and editing, media relations, product marketing, layout/design, and public information operations.
2. Experience in Art, Graphic Design, Commercial Art, Photography, or related field preferred.
3. Must have extensive experience in social media messaging, marketing, planning and management.
4. Must have a good working knowledge of still photography, videography, storytelling, and AP style writing. **A**

5. Must have a basic understanding of military rank structure, Army and Air National Guard mission and vision, and military terminology.
